

## Privacy Policy of Virpa-game

This Application collects Personal Data from its Users and their game-play experience, but all collected Data is treated anonymously.

### Policy summary

#### Personal Data collected for the following purposes and using the following services

The Application requires for a proper function the User's permission to access Personal Data. Personal Data are here: Approximate location and used device Camera.

- Approximate location is required for Us to know about the geographical distribution of our users. Approximate location is required by the Application to enable some of the its functionalities regarding to the game experience. Approximate location is required for the Users to benefit from special functionalities of the Application.
- Camera use is required for the Application to properly work. Photographing real objects related to fire safety enables the User to progress in the Application. Camera use only occurs during Application active use, and it is enable and disabled manually by the User.

Personal Data collected by the Application is collected fully anonymously. It is impossible for the Owner of the Application to trace back who was the Person using the Application.

### Full Policy

#### Owner and Data Controller Types of Data collected

Among the types of Personal Data that this Application collects, by itself or through third parties, there are: Camera use permission, and Approximate location permission. Complete details on each type of Personal Data collected are provided in the dedicated sections of this privacy policy or by specific explanation texts displayed prior to the Data collection. The Personal Data may be freely provided by the User, or, in case of Usage Data, collected automatically when using this Application. All Data requested by this Application is mandatory and failure to provide this Data may make it impossible for this Application to provide its services. In cases where this Application specifically states that some Data is not mandatory, Users are free not to communicate this Data without any consequences on the availability or the functioning of the service. Users who are uncertain about which Personal Data is mandatory are welcome to contact the Owner.

Any use of Cookies – or of other tracking tools – by this Application or by the owners of third-party services used by this Application serves the purpose of providing the service required by the User, in addition to any other purposes described in the present document and in the Cookie Policy, if available.

Users are responsible for any third-party Personal Data obtained, published or shared through this Application and confirm that they have the third party's consent to provide the Data to the Owner.

#### Mode and place of processing the Data

##### Methods of processing

### **Personal Data (or Data)**

Any information regarding a natural person, a legal person, an institution or an association, which is, or can be, identified, even indirectly, by reference to any other information, including a personal identification number.

### **Usage Data**
